**Amendments to the Statues of the cross-university *Promotionszentrum DigiTech* (Digital Technologies and their Application) of the Deggendorf Institute of Technology in cooperation with the Technical University of Applied Sciences Augsburg and Landshut University of Applied Sciences**

**dated 02 April 2025**

Based on Art. 9 sentence 2 in conjunction with Art. 96 (7) sentence 1 and 2 in conjunction with Art. 97 (1) sentence 3 of the Bavarian Higher Education Innovation Act (BayHIG) of 5 August 2022 (German law and ordinance gazette (GVBl.) p. 414, BayRS 2210-1-3-WK), last amended by Section 14 of the Act of 23 December 2024 (GVBl. p. 605) and by Section 8 of the Act of 23 December 2024 (GVBl. p. 632), the Deggendorf Institute of Technology hereby enacts the following statutes:

**Section 1 Amendments**

The Statutes of the cross-university *Promotionszentrum DigiTech* (Digital Technologies and their Application) of the Deggendorf Institute of Technology in cooperation with the Technical University of Applied Sciences Augsburg and Landshut University of Applied Sciences dated 31 January 2024, are amended as follows:

1. The last sentence in Section 2 (1) “It shall be set up on (date XYZ).” is deleted without replacement.
2. In Section 6 (1), the term “BayHIG” is replaced with “AVBayHIG”.
3. Section 7 is amended as follows:
  - a) In paragraph 1, subsection 3, the phrase “in consultation with the Ministry” is deleted without replacement after the phrase “the Steering Committee can decide on the admission”.

- b) In paragraph 3, the phrase “on the Steering Committee” is inserted after “professorial members”, and the phrase “on the steering committee” following the phrase “their deputies” is deleted.
  - c) Paragraph 5 is amended as follows:  
“The doctoral candidate members of the Steering Committee and their deputies are elected by all doctoral candidates belonging to the *Promotionszentrum* for a term of two years. Re-election is possible”
4. Section 8 is amended as follows:
- a) Paragraph 5 is amended as follows:  
“The doctoral candidate members of the *Promotionszentrum* elect one member and one deputy to the Doctoral Committee by simple majority. The doctoral candidate members hold an advisory function on the Doctoral Committee without any voting rights.”
  - b) Paragraph 7 is deleted, and the previous paragraph 8 becomes paragraph 7.
5. In Section 10 (4) the term “Beitrat” is replaced by the term “Beirat”.  
(Note: This orthographic change has no effect on the existing English version.)

## **Section 2 Entry into force and transitional provisions**

- 1. These amendments to the Statutes shall enter into force on 1 April 2025.
- 2. The currently elected members shall remain in office until the end of their term.
